3 . County Council Matters

3.1 Yellow lines near Crossing Terrace - reported on plans to install yellow lines near Crossing Terrace, n an objection has been received from the owner of one of the shops on Holyhead Road. Officer of the County Council is looking into the matter .

Also noted that the proposal to install double yellow lines opposite the entrance to the Gors car park.

The Chairman had received a request for yellow lines on the road to Maes Eilian - property and environment committee to look at the parking situation around the village and send a report to the County Council .
