2 . Declarations of Interest - None received .

3 . County Council Matters

3.1 Tŷ Mawr Site - a statement is due tomorrow by Ieuan Wyn Jones

3.2 Yellow Lines - the work has been done except for Crossing Terrace . Noted that objections had been received from the owner of one of the shops on Holyhead Road .

3.3 The Gors Car Park - The Clerk has contacted Huw Percy in the County Council for advice on the development of the site and pay and display parking . A. Mummery has found old documents can be used as evidence for acquiring new deeds .

4 . Submit and confirm the minutes of 30th July 2013
